

## **Terms and conditions for participation in the 360 DESIGN BUDAPEST event**

### **(House Rules)**

**October 9-19, 2025**

**Buda Castle District**

**1014 Budapest, Táncsics Mihály u. 1.**

#### **(Event venue)**

You can visit the 360 Design Budapest event at your own risk, and our guests accept the House Rules when registering for the event and entering the premises.

The event will be organized according to the current official information, and the organizers reserve the right to make changes!

Rules to be observed:

1. Admission to the event is possible after prior registration at the time specified and in limited numbers, or, if space permits, after registration on site. Wearing the wristband provided upon entry to the event area is mandatory. The Organizer reserves the right to remove unauthorized persons from the event area.
2. For our guests with limited mobility, only the lower level of the event is accessible; the upper level can be viewed via a virtual tour using tablets available on site. We recommend that visually impaired guests visit the event with an escort.
3. Food, drugs, any objects classified as weapons, narcotics, pyrotechnic devices, and other items specified in Government Decree 175/2003 (X. 28.) as particularly dangerous to public safety are prohibited from being brought into the event area.
4. Smoking is prohibited throughout the entire venue, including the use of smoking devices, and the use of open flames is also prohibited.
5. Only beverages purchased at designated locations may be consumed within the event area.
6. Guests may only stay in the areas designated for them on the event site and may not enter restricted areas.
7. A 24-hour camera surveillance and recording system is in operation on the event site.
8. Due to the architectural characteristics of the building hosting the event, the internet connection may be unstable, which may make it difficult to scan the QR codes next to the objects.

9. If you notice any irregularities (e.g., fire, burst pipe, abandoned package, etc.), please notify security personnel or any of our staff immediately!
10. Please take care of your valuables! We are not responsible for lost items! We are not responsible for valuables left unattended on the premises or kept by our guests!
11. The event cannot be visited if you are ill. The organizers exclude all liability in the event of illness or injury among visitors at the venue. If any health or other restrictions relating to the event come into force during the event, all visitors are obliged to comply with them.
12. When visiting the event area, only the equipment and furniture provided for this purpose may be used, at your own risk. The use of exhibited objects and furniture is prohibited, except where specifically indicated by the Organizer. The Organizer is not responsible for any damage or injury that may occur during the event. In the event of damage, the Organizer will immediately exclude the person responsible from the event and initiate legal action, and may also claim compensation for the damage.
13. Due to the nature of the venue, animals are not allowed at the event.
14. The Event may not be used to convey political content, campaign messages, hate speech, or incitement through clothing, accessories, performances, or other activities.
15. The following persons are not allowed to participate in the event and must leave the premises immediately:
  - a. those who are present on the premises of the event without a valid wristband;
  - b. those who endanger the life, physical integrity, or property rights of other persons;
  - c. engage in disorderly conduct or conduct that warrants police intervention; incite hatred against members of other social groups or cause unrest among the audience through aggressive behavior;
  - d. fail to remove prohibited items from the area despite being asked to do so;
  - e. wishes to use the event for purposes other than cultural entertainment/the purpose of the event;
  - f. does not behave cooperatively despite requests from the organizers.
16. The Organizer will make video and audio recordings of the event for promotional purposes. Participants will necessarily appear in the recordings. Participants agree that the Organizer may use the recordings exclusively for advertising or press release purposes without any restrictions in terms of time, space, or any other limitations.
17. Audio, image, and video recordings of the exhibits, installations, and video content displayed at the event are permitted. In the case of public display, the following captions are recommended:
